Skills and Training in Action Research (STAR) Fellowship Using College Data to Connect Students with Safety Net Benefits ("Data-to-Benefits Project")

Request for Applications

The Urban Institute is seeking **one** part-time consultant who will be designated as a Skills and Training in Action Research (STAR) Fellow. A STAR Fellow is a current or recent student who has lived expertise relevant to this position. As a STAR Fellow, you will be a paid member of the project leadership team while also supporting project operations and learning about how to engage in effective research geared toward informing action. STAR Fellowships are an initiative under the <u>Student-Parent Action through Research Knowledge (SPARK) Collaborative</u>.

As a STAR Fellow, you will work with a team to identify colleges that are using their own data in innovative ways to connect students—particularly student parents—with social safety net benefits (e.g., cash, food, housing, and child care assistance). You will support virtual (i.e., online) site visits to up to six colleges, which will consist of interviews with administrators, students, and possibly other staff members to understand how they are leveraging data to promote program access. You will be invited to engage with a policy advisory group that will inform the project. And you will be invited to contribute to and coauthor written products for policy and practitioner audiences. This position is supported by a grant from the Annie E. Casey Foundation.

We are seeking candidates with direct experience relevant to being a parenting student and accessing public safety net benefits.

This contracted position is budgeted until mid-2025, though the project could be extended. We estimate 80 hours for the STAR Fellow (expected effort is about 10-20 hours per month). Compensation will be paid based on hours worked at \$53 per hour as a consultant.

You are welcome to consult remotely and on a nontraditional work schedule. Though there may be prescheduled project meetings you will be asked to attend, we are glad to work with you to accommodate scheduling considerations.

What you'll do:

- Join team planning and coordination meetings.
- Contribute to project strategic and logistical planning, including developing the research work plan where we identify the strategy for the virtual site visits and develop protocols (i.e., question lists) to guide the data collection.
- Join the policy advisory group meetings to understand more of the context around this work. We may ask you to take notes or otherwise support the operations of the meetings.

A successful candidate will:

- Be a current or recent graduate or undergraduate student (enrolled within the last two years: spring term 2023-current term). Students in workforce or noncredit programs are also eligible.
- Demonstrate interest in issues related to parenting college students and the social safety net.
- Have experience with qualitative research or an interest in learning qualitative research methods.
- Be knowledgeable about or interested in learning about social safety net benefits and college data systems.
- Have experience with and willingness to write for internal and external audiences, communicate verbally and in written form, work with a team, work independently, think critically to solve problems, and manage time effectively.
- Understand and demonstrate respectful approaches to engaging and communicating with individuals of differing backgrounds and experience to support collaborative projects.
- Employ strengths-based perspectives when talking about particular groups or particular contexts.
- Show a strong willingness to learn, adapt, and suggest improvements.
- Preferred but not required: Has knowledge of college data systems, including financial aid data, student records data, or other student-level data that colleges may have access to.

We value lived and ongoing experience and expertise, and we encourage candidates with personal familiarity with parenting while in college, and/or other parallel lived experiential expertise to apply.
